ENTERTAINMENT/OPTIONS

E & J Entertainment hereby agrees to provide a DJ Service for the Client. Said DJ service shall consist primarily of providing musical entertainment in a specific music format, as well as emceeing the event. The DJ will be dressed in formal attire unless otherwise requested.

EQUIPMENT AND MUSIC

All equipment used by E & J Entertainment is professional-grade DJ audio and lighting equipment. We keep a full complement of back up equipment on-site in case of equipment failure. E & J Entertainment will also provide the music, comprised of several thousand songs, all legally purchased and stored on CDs or in MP3 format on a computer.

COST

The Client in consideration of the DJ service to be rendered by the DJ, and the mutual promises contained herein, hereby agrees to pay to the DJ the following consideration: A non-refundable deposit of \$100 is required to secure the services of E & J Entertainment for the engagement. This amount shall be applied toward the Performance Fee. The Performance Fee is \$_____ for the six-hour time frame outlined above. Services requested that exceed the six-hour time frame will be charged at the rate of \$50 per half hour, payable the day of the engagement. It may not always be possible to provide additional performance time. However, when feasible, requests for extended playing time will be accommodated.

DEPOSIT DUE DATE: _____

A tentative reservation is being held for Client's event until this date. Entertainment Agreements received after this date are subject to availability.

PAYMENT

Payment may be made with personal/company/cashier's check, or cash. Please **MAKE ALL CHECKS PAYABLE TO JASON PAETZ**. (There will be a \$20.00 fee charged for all returned checks.)

GRATUITIES

Gratuities given to your DJ Entertainer are made at the Client's sole discretion. 10% is customary for an excellent performance.

TO CONFIRM THIS AGREEMENT

(1) FILL OUT AND SIGN THIS CONTRACT (must be 18 yrs. or older) **AND RETURN IT TO THE DJ**. DJ will type up contract and return a signed copy to you for your records. **(2) THE DEPOSIT MUST BE RECEIVED BY THE DUE DATE TO GUARANTEE SERVICES FOR YOUR EVENT.**

CANCELLATION:

This Agreement cannot be canceled or modified in writing by either the client or the DJ. If Client initiates cancellation less than 60 days prior to the event, then only the deposit will be forfeited. If Client initiates cancellation less than 30 days prior to the event, then Client is responsible for the total fee OR may forfeit deposit only by signing a new Entertainment Agreement with DJ within 14 days of cancellation for a substitute engagement performed in the following 6 months. Rescheduling for events canceled due to inclement weather shall be accommodated without penalty whenever possible. Rescheduled events are subject to availability.

PROVISIONS:

The Client shall ensure that (1) performance facility provides DJ with within 25 feet of performance area; (2) Table shall be within 25 feet of (3) prong grounded) for audio and/or a reliable 20-amp circuit (3-prong grounded) for lighting effects; (3) facility is open at least 3 hours prior to scheduled start time for DJ set-up; (4) facility meets all federal and state safety regulations and has all appropriate music licenses and performance permits where applicable; (5) reasonable steps will be taken to protect DJ's equipment, personnel, and music, and crowd control will be provided if warranted; (6) for outdoor performances, shelter is provided that completely covers and protects DJ's mobile equipment from adverse weather conditions.

Client accepts full responsibility and is liable for any damages, injuries, or delays that occur as a result of failure to comply with these provisions. In the event of circumstances deemed by DJ to present a real or implied threat of injury or harm to DJ, equipment, or recordings, then DJ reserves the right to cease performance until such time as Client resolves the threatening situation. DJ further reserves the right to deny any guest access to recordings or equipment. In the unlikely event the DJ's performance is delayed, liability is limited to providing Client with performance time equal to time lacking.

This Entertainment Agreement supercedes all others for the aforementioned event date and is subject to the laws of the State of Michigan.
